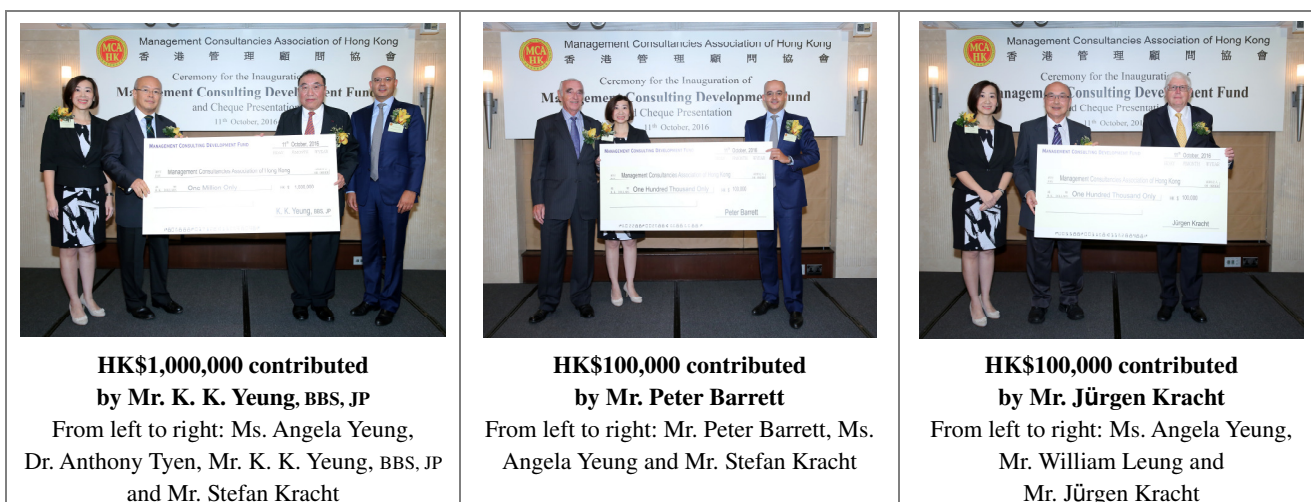

As addressed by Chairperson, Ms. Angela Yeung, at the Cocktail Reception, the objectives of the Fund are to promote “management consultancy” to universities’ students who are prospective new recruits of management consultancy firms, and to support the further development and training of applicants who are new recruits in the field of management in general and management consultancy in particular and encourage their continuing professional development in the management consulting industry.

The idea was well supported by founder members Mr. Peter Barrett and Mr. Jürgen Kracht. The General Committee of MCAHK then established a task force committee chaired by General Committee member Dr. Anthony Tyen, together with General Committee member from KPMG and the Chairperson, to work out the details including the requirements, application and selection process, the usage and governance of the Fund.
